

**FY 2022 Continuum of Care (CoC) Program Competition NOFO**  
**CoC Estimated Annual Renewal Demand Report**

As stated in Section I.D of the FY 2022 CoC Program Competition NOFO, approximately \$2,794,000,000 is available in the FY 2022 CoC Program Competition, including at least \$52 million available for Domestic Violence (DV) Bonus projects and approximately \$80 million available for non-competitive renewal and replacement of expiring YHDP grants. HUD may add to the total amount with any available funds that have been carried over or recaptured from previous fiscal years. All requirements in the FY 2022 application process, including requirements for the entire CoC Consolidated Application and the total amount of funds available, are included in the NOFO.

The following Estimated ARD reports that include each CoC’s Preliminary Pro Rata Need (PPRN) amount, Estimated ARD, Tier 1 based on estimated ARD at 95 percent (Section II.B.11.a of the NOFO), CoC Bonus (Section III.B.2.c of the NOFO), DV Bonus (Section III.B.2.h of the NOFO), CoC Planning (Section V.B.3.f.(9)(a) of the NOFO), and UFA Costs (Section V.B.3.f.(9)(b) of the NOFO).
